Storage Rules/Terms & Conditions:

1. Lessee agrees to pay \$6.00/linear foot or \$1.00/linear foot (outside storage) (footage to include tongue of trailer, spare tire, etc.) per month for storage from date vehicle/item is delivered to the Fairgrounds through date of removal.
2. Discount if paying in full, \$5 per linear foot. Otherwise, will pay ½ when item goes into storage and ½ April 1st.
3. Winter Storage begins November 1st and ends April 30th.
4. A late fee may be applied if any vehicle is stored beyond the agreed-upon exit date of April 30. Contact the Fair Office at info@cheshirefair.org, or call 603-357-4740. ***Arrangements must be made at time of drop off in the Fall of 2023.***
5. Storage placement it is best to call into the office to schedule based on when you need to remove your item in the spring. Please call 603-357-4740 to arrange.
6. Early pick-ups will be the last placed inside the building. Arrangements for Spring of 2024 pick-up **MUST** be made at time of drop-off in the Fall of 2023.
7. Lessee agrees to furnish a policy of Property Damage Insurance for theft, fire, windstorm, and extended coverage for the storage period. No items will be stored unless current copies of insurance policy and registration have been supplied to Lessor. Copies of insurance and registration information will be kept on file in the Fairgrounds Office.
8. Lessee agrees that no containers of flammable or explosive substances are in vehicle to be stored. ****CFA requires that you turn OFF propane tanks and DISCONNECT batteries****
9. Lessor agrees to furnish storage to lessee but assumes no liability for theft, collision, fire or damage in any case, including but not limited to tarps, trailers, etc. **Lessee acknowledges that the Cheshire Fair Association, Inc. maintains no insurance coverage for non-owned property stored pursuant to this Agreement.**
